GENERAL RULES AND REGULATIONS APPLICABLE TO ALL DISCIPLINES

1. Payments are due on the closing date. Proof of payment must be emailed to percoffice@gmail.com by entry closing date , failing which the entry will not be processed.
2. No horse may enter the show without a horse flu vaccination and AHS, please complete details (date & batch number) on entry form.
3. No refunds/credits will be made in respect of cancellations / scratchings after closing date of entries.
4. Times will be up on the notice board 24 hours prior to the commencement of a show, and the final programme will be e mailed to all members of the PERC. Non-Members may send the club secretary an e-mail requesting the programme. No times will be given over the phone.
5. Please note that the only time that is exact is the starting time for the day, all other events will run on.
6. Insofar as possible, the program and conditions relating thereto will be adhered to. However, the Organizing Committee reserves the right to make alterations in the event of unfavourable weather conditions or any other unforeseen circumstances. The Organizing Committee further reserves the right to combine, vary, divide or cancel classes if insufficient entries are received. Depending on entries classes may be combined and/or handicapped and separate prizes will not be awarded. The show holding body of the PERC reserves the right to limit entries, depending on the total number of entries received per class.
7. Should the show be cancelled for any reason only 50% of entry fees will be refunded. No entries will be refunded if the show is postponed.
8. The SAEF , DSA, SASA, SAEQA, SASJ, ESA and the Port Elizabeth Riding Club , including their staff , organizers , committee members and all officials appointed by them , shall in no way be held responsible for any damage, loss or injury sustained to or by owners, competitors, grooms, horses , members of the public or any other person or persons or their property at the PE Riding Club for the duration of show. By entering this show you hereby indemnify them from any and all claims in connection with your participation in the show.
9. Please note that all PERC arenas are out of bounds at all times except during shows.
10. All horses / ponies that are prone to kicking must wear a red ribbon on their tails
11. No fires are allowed anywhere on the premises at any time except in the designated braai area
12. By entering a stallion at the PERC, the competitor & owner agree to the following :
 1. Competition stallions remain the responsibility of the owner and rider at all times and are expected to have public liability against any loss, injury or damage that might be caused by the stallion
 2. It is the responsibility of the owner & rider to ensure that the stallion cannot exit the stable allocated to it on its own/or with the help of another horse or uninformed person.
 3. The stallion may only be removed from the stable during the show for exercise, preparation or competition & only by a responsible handler or rider.
 4. Under NO circumstances shall the covering of mares be allowed to take place at the PERC premises.
 5. All stallions must wear a yellow tag on their bridles at all times.
13. All dogs must be on leads
14. PERC ground staff will close all perimeter gates as well as the gates of the stable block at the end of each show day. PERC will not accept responsibility nor liability for any gates that are thereafter left open by riders , owners or grooms.
15. It is the responsibility of all competitors to ensure they and their horses are correctly registered with all National and Provincial bodies. All FEI and SAEF rules shall apply.

COVID 19 RULES AND REGULATIONS APPLICABLE TO ALL DISCIPLINES

This show will be run under Covid 19 restrictions as gazetted by the Government and SAEF guidelines in force at the time. All persons entering the venue agree to comply with all SA Government, Minister of Sport and SAEF Covid 19 lockdown regulations. This document must be read in conjunction with the SAEF Sport Ready, Safe Sport Resumption Covid-19 Document. All Show Holding Bodies must comply with the Government Gazette and approved SAEF sport ready document as issued by SAEF and set out on the SAEF website www.saeef.org.za. By submitting your entry you agree to comply with all such regulations.

- **Riders may only be accompanied by 2 additional persons (driver , groom or instructor). Riders under the age of 18 may have a 3rd person in attendance (guardian or parent).**
- No spectators and no members of the public will be allowed access to the venue.
- Riders are required to arrive at the venue no more than 45 min before their allotted time slot. This allows enough time to offload and tack up to be ready for their class. **Riders and accompanying persons are required to leave the venue within 30 min after the end of their final round.**
- A Covid 19 Compliance officer will be appointed.
- All riders and their accompanying persons must pre-register on the ShowWave Covid screening and access control system , and must bring their QR code to the gate on their device or a paper copy for scanning. **Nobody will be allowed access without this QR code. People will also be scanned on exit.**
- **Everyone entering the venue is required to pre-register on the ShowWave system , including officials, medics, judges, riders, instructors, staff and grooms, failing which entry to the venue will be denied.** You have to allow your temperature to be taken and recorded on the system , your hands to be sanitised , and you must have a mask.
- This system is used to compile a detailed attendance register which PERC is required to submit within 24 hours of the end of the Show , and which must include all details of each person entering the venue for contact tracing purposes, and must keep such document for 6 months after each show. Please cooperate to help us to meet this requirement.
- Any person who is suspected to have been in contact with an infected person, or who has an elevated temperature or any other symptom , will be refused entrance and advised to leave the venue and self isolate or contact their Doctor
- More than 2 horses arriving on a single horsebox / truck will be allowed to enter and park at the designated area, however the riders themselves will not be granted access until 45 mins before their slot. Please only bring the minimum number of grooms.
- **The social distancing requirement for individuals and riders on horseback is 2m. For parked horseboxes it is 5 m.** Please tack up and untack close to your vehicle / horsebox so as to respect social distancing requirements.
- Riders will only be allowed into each warm up arena immediately preceding their round / class and a maximum of 5 horses will be allowed in the warm up arenas at any point in time.
- Riders and horses must return to their horsebox in between rounds, and for purposes of cooling down their horses.
- Where applicable , PERC will supply course builders for the main and warm up arenas. Only PERC staff may touch or make any adjustments to the jumps and course.
- **Masks are to be worn at all times except when mounted on a horse.** This includes grooms, instructors, parents and officials. Not wearing a mask in public is a criminal offence.
- Riders must provide their grooms with disposable gloves when accessing water taps or wash bays.
- **No socialising, congregating , spectating nor gathering will be permitted.** Riders and grooms waiting for their next class must return to the parking area to wait next to their horseboxes. Riders and their accompanying persons are required to leave the venue 30 min after their last round. Spectating at a sports event is a criminal offence.
- The kitchen will be open with a limited menu of pre-packed / pre-sealed food.
- Medics will be on duty.
- **The main gate on Bergeus St is closed except for officials, staff, volunteers and service providers only**
- Although placings will be awarded, no prize giving will take place after each class, and if rosettes are awarded they must be collected from a designated area. Prize monies will be paid by EFT or credited to a members account. Results will be published online.
- Where applicable , course walking is allowed before each class subject to 2 m social distancing requirements , masks must be worn.
- **A maximum of 150 people are allowed at the venue at any point in time, including officials, instructors, riders, grooms, drivers, staff and parents**
- Neither SAEF , SASJ , SASA , SAEQA , ESA , DSA PERC nor any of their committee or staff members accept any responsibility for any judge , competitor , official , groom , driver , parent or instructor that might contract Covid 19 at any graded or ungraded show or exercise , training or practice

sessions , including Open Days and Ride and Go events. All persons entering the venue do so at their own risk. All entries are at the risk of the Competitor and their accompanying persons. Compliance Officers are responsible for ensuring that the correct and latest Covid protocols , procedures and guidelines are adhered to.

- Note that SAEF Insurance will not cover anyone, should a person contract Covid-19 whilst attending/participating in a show, hosted by the approved Show Holding Body .
- **All persons entering the venue accept responsibility for their own health and safety , and for that of others ,and for complying with these regulations**

We request that everyone please respect the measures put in place by PERC for everyone's health and safety. Please be respectful of all staff members and volunteers.

PERC recognizes its obligations to implement the statutory requirements imposed on it , specifically those relating to Covid 19. PERC has the obligation to deny access or to remove anyone from the venue who does not meet all Covid 19 requirements and guidelines.

Entry Fees

R130 per graded class (Welcome, Novice, Intermediate, Open) and R 105 for Special Recreational classes (ungraded).

The entry fee includes the following levies:

SAEQA levies: R 16 graded and R 14 recreational

EDTS levy: R 5.13

Admin / medic levy: R 30 recreational and R 40 graded

The entry fee excludes:

Ground Fee of R 40 per horse per discipline (members and non members)

For PERC members: Competitor Fee of R 80 per rider per show

For non PERC members: Temporary membership fees of R 150 graded and R 125 recreational per rider per show

- Please make sure the height you are jumping for your Equitation test **is not higher** than your graded jumping height.
- Cross entries will be allowed between Pony Riders & Junior Rider Classes. However, the SHB will not be held responsible if the classes clash. Both classes cannot be ridden if there is a direct clash.
- **All Athletes must be registered with the SAEF, a Club of their choice & SAEQA.**

You will receive a message from ShowWave (an international dialling code +1(228) 300 2799 that includes a code in blue text eg. 000012-345678.

Copy paste only this code and send it back to the number +1(228) 300 2799 that sent it to you.

You will then receive your QR code for this event by whatsapp and by email.

Previously registered for PERC Summer Show:

Enter your name and surname. The system will recognize you and ask you to confirm your cell and email address. Then click on "Validate", you will be required to update your answers to the questions

Click on "Submit" (You will not be able to submit if any mandatory questions are not answered)

You will then receive an email version of your same QR code that you got for the Show

You will **not** receive it again by whatsapp, you can use the previous (Show) code that you originally received by whatsapp for that show, but this will only be valid if you have registered / validated your data and questions for the Practice Jumping.

In a nutshell, you receive 1 and only 1 QR code that is yours forever for **all** PERC shows, but you must still register / validate your answers for each show to update your health questions and other data for each show. Your code will stay the same, but the data / answers behind it will be updated for each new show.

So your existing QR code will only work if you have validated your data for each new show.

General:

Your code will be scanned from your cell phone or paper copy at entry to the venue and temperatures recorded. You will also be scanned on exit from the venue.

If you have access to a printer, then PLEASE print and take the QR code to avoid scanning delays due to reflection of the sun on a cell phone screen – this will speed up your entry.

A rider may register their groom for the sake of convenience but please enter the groom's personal details and cell number / email. If they don't have a cell phone / email then the rider can enter their own cell / email and **you** will then also receive your groom's QR code. **But please remember which code belongs to who when your codes are scanned at the gate on entry and exit!** This caused some delays at the previous show.

All officials, staff, medics, volunteers, judges etc must also pre-register, please just tick the appropriate box on the online registration form.
